Expenditure Summary Report – June 2011

Out of Country Data Expenses

Mr. Griffin submitted a Spokane Employees' Retirement System Policy and Procedure for Out of Country Travel Expenses. The policy calls for reimbursement to the Director for cell phone and data charges when the Director is traveling internationally; it is effective July 1, 2011. Mr. Griffin stated that having his Blackberry is essential for monitoring the investment portfolio, as there are certain responsibilities that cannot be delegated. In July, Mr. Griffin was out of the country when entrance into the Altairis Limited Partnership, which had been closed to new investors, became available unexpectedly. Not being available to address issues in a timely manner may have caused a delay or a missed opportunity to enter the fund. The phone and data reimbursement policy was discussed and supported by the Board at its February 23, 2011 meeting.
