# Jayson Davidson, Hyas Group, 2014 4<sup>th</sup> Quarter Investment Performance Report

Mr. Davidson presented the 4<sup>th</sup> Quarter 2014 Performance Report. The Fund's five-year return at December 31, 2014 was 9.06% with a three-year return of 11.84% and a return for 2014 of 5.34%. There was discussion about current and longer-term performance relative to policy benchmarks.

Hyas Group will maintain the watch status for performance in violation of policy criteria on the Champlain Small Cap Fund, Epoch International Small Cap Fund, Metropolitan West High Yield Fund, and Sterling Mid Cap Value Fund. The Post Limited-Term High Yield Fund, Principal Global Investors REIT Fund, PIMCO Global Advantage Bond Fund and PIMCO Commodities Plus Fund will also remain on watch for non-performance, qualitative reasons related to recent personnel changes. It was noted that the PIMCO Low Duration Bond Fund, which was previously on watch status, was removed from the SERS portfolio in December.

Mr. Davidson distributed a separate document that provided information related to the SERS portfolio performance versus the \$250 million to \$1 billion peer group universe within the Investor Force database. Going forward, Hyas will plan to include this data within the performance report.

Hyas Group will prepare manager search reports to evaluate alternatives in the high yield bond asset class and the international small-cap asset class. The reports will be presented at the next quarterly meeting.

It was announced that SERS has hired a new Retirement Director. Hyas Group will plan to include a discussion on conducting a new asset allocation study in their initial meetings with the new Director.

### Minutes of the January 28, February 25, and March 4, 2015 Meetings

Mr. Bjork discovered an error on the January 28, 2015 minutes in which he was a guest and not listed.

Jon Snyder moved and Mike Cavanaugh seconded the motion to approve the minutes of the January 28, 2015 as amended, and the February 25, 2015 and the March 4, 2015 meetings as distributed. The motion passed unanimously.
